Long Term Plan

The Chair discussed the 4 key items that the HRRA believe are important for the community and which we will raise in our LTP submission:

- 1. Revenue collection does the community support further parking costs in the community.
- 2. Water supply needs to be given priority.
- 3. Sewage Treatment needs to be given priority.
- 4. Walkable Village- requesting that money is allocated annually to assist with the ongoing development of this vision.

Deputy Mayor Mclean addressed the AGM on the above points:

Looking at ways to capture revenue from the 320,000 visitor's pa for infrastructure. Currently ratepayers are paying all these costs through rates and fees. This is the motivation for charging for parking.

Concerns raised from the floor that if people are charged for the visitor's carpark and the shuttle bus that they'll park throughout Hahei village.

Recommends the community submit strongly on our water and wastewater needs to support Council with the Three Waters.

Councils have very restricted budgets for 'nice to have', but Deputy Mayor Mclean suggests submitting that a small fund be available annually.

Robust discussion from the floor regarding paid parking, particularly at the beachfront.

A suggestion that parking at the beach be timed rather than charged for to manage the peak.

User pays for overseas visitors, but not fair to expect kiwis to pay for parking at the beach. The management of exceptions is also a cost.

Moved by Bill Stead that the meeting accepts the planned 4 point proposed submission/2nd Andrew Watson. Passed by a show of hands.

We should have an outcome shortly and the ramp is in storage in Whitianga in the meantime.
